## **Superintendent's Report**

Dr. Thompson presented the following information:

### **Teaching and Learning**

Camp MacKenzie Trip Update – Diane Olenchek explained what the Camp MacKenzie trip entails, the costs associated with this trip, and answered questions. Peggy Moede raised a concern about the concentration of ticks in the area where camp is held and asked that we make sure that parents are made aware of this issue on the permission slip.

Curriculum and Programmatic Review Implementation Update for PE and Health – Chris Evans and Mike Lescohier reviewed the updates to the PE and Health programs as a result of last year's Curriculum and Programmatic Review process. The following are examples of updates:

- Offering a wider variety of units to include Rugby, Cricket, Disc Golf, an increased focus on the climbing wall, and use of Heart Rate Monitors
- Increase fitness testing from 2 times a year to 3 times a year
- Developing a Canvas class pages that will be used by all students to see class materials, and be used by students that are unable to participate due to injury or absence
