#### CALL TO ORDER

#### **Superintendent's Report**

Dr. Thompson presented the following information:

2018-19 Student Enrollment Update – Dr. Thompson presented the current enrollment numbers for the school year which includes 462 students.

Referendum Communications and Community Engagement Planning –Board members finalized details on which members will attend local area meetings to answer any community member questions regarding the Referendum. Suggestions were also made to do a Backpack Stuffer on November 2.

2018-19 Budget Updates – Jeremy Struss updated the Board on the proposed changes to the adopted budget at the Annual Meeting in August due to student enrollment numbers.

Monthly Financial Overview – Jeremy Struss updated the Board on the July and August revenues and expenditures.

Opening of the 2018-19 School Year – Mr. Moore reported that the year started off really well with the only real concern being busing as there are new drivers and they are getting used to the routes. The Strong Start Conferences were well received by parents and staff alike.
