SPECIAL SCHOOL BOARD MEETING

March 23, 2015

CALL TO ORDER

John Fuhs, called the meeting to order at 6:02 p.m., read the Notice of the Meeting, and led those in attendance in the Pledge of Allegiance.

Andy Anderson motioned to approve the agenda. John Quast seconded and the motion carried 4-0 on a voice vote.

INFORMATIONAL ITEMS

Superintendent's Report

Ms. Thompson presented the following information:

Emergency Operations and Crisis Planning Review with Members of Local Law Enforcement Agencies – Captain Lisa Panas and Lieutenant Paul Beal of the Waukesha County Sheriff's Department and Hartland Interim Fire Chief Dave Dean presented the board with a review of the emergency operations and crisis response planning drill at Swallow in August 2014 and previewed recommendations for Swallow's Crisis Management Plan.

<u>Emergency Operations and Crisis Management Plan Updates</u> – Administration will revise the Crisis Management Plan and present an updated plan for board approval at the April board meeting.

<u>Process and Timeline for Updating the Employee Handbook</u> – The Employee Handbook is currently being revised along with teaching and support staff. A first draft of the employee handbook will be presented at the April board meeting.

<u>Annual District Survey Launch</u> – Staff, Parent, and Student surveys launched on Friday, March 20th. The survey will be active for two weeks. *School Perceptions* will review and compile the data to be presented later in the spring.

<u>Planning for Strategic Planning Kick-Off Date</u> – The board reviewed potential dates for a board organizational meeting as well as possible dates for a May board meeting and a kick-off meeting for the strategic plan.

<u>Bi-Annual Report on Bullying Prevention and Response</u> – Mr. Lemke presented the bi-annual report on bullying prevention and response. No formal complaints were made in the 2014-15 school year; the District received three requests for investigation.

<u>Update on Academic and Career Plan Implementation</u> – Mr. Morgan reviewed the Academic and Career Plan Implementation that he has worked on this year and will continue to work on throughout next school year.

Principal's Report

Ms. Crockford and Mr. Lemke presented the following information:

<u>March in Review</u> – Swallow student Willem Paulson qualified for the State Geography Bee. Parent/Teacher spring conferences took place earlier in March as well as social activities such as the Father/Daughter Dance, Spirit Week, and Hoops for Heart including the Staff vs. Student basketball game. Administration held two parent meetings on target-based grading which were well attended.

<u>Staff Development Update</u> – The staff began to review their current learning targets, update their assessments, and worked to plan for the 2015-16 school year. Science teachers demonstrated an example of aligned assessments, and subject-level teachers worked on revising their grade-level targets and realigning targets from one grade to the next.

CELEBRATIONS AND COMMENDATIONS

Ms. Thompson recognized parent volunteer Susie Polentini for organizing Biz Town for Swallow's 5th grade students. She also commended Mike Lescohier and Mike Hodel for their outstanding programming of staff wellness activities which assisted the district in earning a 3% Wellness Discount on the upcoming health insurance renewal.
