SCHOOL BOARD MEETING

September 15, 2014

Present: Karen Trimble, John Fuhs, John Quast, Rebecca Morrison, Andy Anderson, Melissa Thompson, Joan Fritzler, Kyle Moore, and Kim Zabel.

CALL TO ORDER

Karen Trimble, called the meeting to order at 6:30 p.m., read the Notice of the Meeting, and led those in attendance in the Pledge of Allegiance.

John Quast motioned to approve the agenda. Rebecca Morrison seconded and the motion carried 5-0 on a voice vote.

CELEBRATIONS AND COMMENDATIONS

Tim Lemke and Rachel Crockford showcased the Hawk's Nest, a learning space for interventions and extensions which has been recently redesigned and refurnished. This work was funded by an Innovation Grant through a partnership with the Swallow Education Foundation.

CITIZENS' FORUM

No comments were made.

INFORMATIONAL ITEMS

Superintendent's Report

Ms. Thompson presented the following information:

<u>Employee Relations</u> – The Board reviewed the proposed 2015-16 Arrowhead Area Schools Calendar, which will go to the Employee Relations Committee for further discussion.

<u>Finance and Operations</u> – The Board discussed the referendum planning project, the generator project, and the emergency preparedness drill. The community will be invited to participate in a Facility Studies Committee to assist in determining next steps in the referendum planning process in the coming weeks.

<u>Teaching and Learning</u> – Ms. Thompson updated the Board on enrollment for the 2014-15 school year as of September 15, 2014 and Ms. Crockford reviewed the professional development provided at the beginning of the school year.

<u>Professional Development Update for Early Release Days</u> – Mr. Moore forecasted upcoming professional development days and broad topics of focus during early release days in September, October, and November.

<u>Start of 2014-15 School Year</u> – Mr. Moore reviewed the beginning of the 2014-15 school year at Swallow.

<u>Extra Service Proposal Update</u> – Mr. Moore discussed the process for extra service proposals for the coming school year. The Board will be asked to approve extra service proposals at the October Board meeting.

<u>Approval of 66.0301 Agreement with the School District of Waukesha</u> – Karen Trimble moved to amend the motion to approve an agreement with the School District of Waukesha for reimbursement of sub costs as presented. John Quast seconded and the motion carried 5-0 on a voice vote.

<u>Dates for Board Sub-Committee Meetings</u> – The Policy, Teaching and Learning, Finance and Operations, and Employee Relations Committees discussed tentative upcoming meeting dates.

(b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations, and Wisconsin Statute 19.85 (g), "conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved."
