## SUPERINTENDENT'S MESSAGE

To the citizens of the Swallow School District:

As we enter our 181st year of Inspiring Excellence, Swallow's commitment to our students and their success has never been stronger. Early last year the Wisconsin DPI announced that the Swallow School District earned a 92.6 and rating of Significantly Exceeds Expectations for the 2021-22 school year, making us the one of the highest scores District statewide, with subcategory scores of 93.8 for achievement, 95.2 on track to graduation, and 89.7 for target group outcomes. In addition, Swallow earned top rankings in Wisconsin for the elementary and middle schools in Wisconsin from Niche.com and U.S. News and World Report rankings have Swallow as part of an elite group of schools of more than 80,000 across the US to garner high rankings for both elementary and middle schools. Swallow is rated 5<sup>th</sup> highest in the national for Middle schools and 26<sup>th</sup> highest in the nation for Elementary schools. Our Swallow staff is ranked as the having the #2 best public school teachers in the State of Wisconsin. These top state and national ratings are attributed to highest levels of collaboration and teamwork amongst families, the community, and our entire Swallow staff. THANK YOU for making this monumental work possible—the benefits for our students are significant and underscore our district values of Students First, Continuous Improvement, Community Engagement, Fiscal Responsibility, and Respect and Honesty which guide our planning and decision-making at all levels.

The closing of the 2022-23 school year saw the approval of the District's new leadership and working towards continuous improvement work with the School Board. For the health of the district, together we will be focusing on two Board Ad Hoc committee. One of the committees is the Ad Hoc Financial Committee and the other committee is the Ad Hoc Superintendent Transition Committee. We are maintaining our targeted focus on student growth and engagement considering their social, emotional, and academic needs and interests. This happens because of our emphasis on knowing each child as an individual first and actively engaging them in the learning process to set goals and take ownership for learning outcomes. This can be seen daily during SOAR, our intervention and extension block, and in the 1:1 conferences students enjoy with staff to personalize learning for them.

While developing our students is our core business, this cannot happen without a significant investment in Talent Management of our employees. The foundation of this focus is our recruiting and onboarding process which leverages existing staff relationships with colleges, universities, and networks of colleagues coupled with a mentoring program. This engages all employees and assists with retention efforts measured through a streamlined method of feedback including our evaluation and professional growth model with coaches and supervisors.

Our Swallow mission is paramount to set goals in the areas of Finance and Operations. Ensuring students are placed first only happens when the district's financial priorities and operational processes support this value. The district's budget and requisitioning through Board policy and processes requires adherence to explicit priorities to ensure monies are being spent most directly on outcomes and student support.

The district is in the top 5% of all school districts in the state for its Academic Return on Investment as a result of this diligence. The Board and administration work collaboratively together to ensure the fund balance can support short and long-term district needs to avoid short-term borrowing and the incurrence of interest costs. Despite passage of a referendum in the 2018-2019 school year, the Mill Rate has decreased significantly over the course of several years. Notably, this does have significant impact our budget future.

In the year ahead, we are continuing our continuous improvement strategic work to ensure our students receive a world-class education and carefully manage the investment of residents in our district. I look forward to the opportunity to meet you over the weeks ahead and months ahead our school events.






**Group Scores**

## ANNUAL MEETING REPORT

### **DEFINITION OF TERMS**

#### **Funds**

Fund 10 - General Fund: Used to account for all financial transactions relating to the district's current operations except for those required to be accounted for in other funds.

**Fund 21 - Special Revenue Trust Fund:** Used to account for trust funds that can be used for district operations. The sources of such funds are gifts and donations from private parties. Funds are expended pursuant to donor specifications.

**Fund 27 - Special Education Fund:** Used to account for special education and related services, including those funded with state or federal special education aid.

**Fund 39 - Referendum Approved Debt Service Fund:** Used to account for transactions related to the repayment of debt issues that were approved by referendum.

**Fund 41 - Capital Expansion Fund:** Used for building and site maintenance or repair projects financed through a tax levy within the revenue limit.

Fund 46 – Long Term Capital Improvement Trust Fund: Used for building and site capital projects financed through transfers from the General Fund.

Fund 49 – Other Capital Projects Fund: Used for capital projects financed through referendum approved debt.

Fund 50 – Food Service Fund: Used to account for transactions related to pupil food service activities.

### Revenues

Local Sources: taxes, interest, student fees

Payment for Services: open enrollment in aid transfer

State Sources: general aid, transportation aid, library aid, per pupil aid, special education aid

Federal Sources: ESSA/Title grants, IDEA Grants, ESSER II & III

Other: miscellaneous and adjustments







After a review of the district expenditures during the 2021-2022 school year, and the proposed 2022-23 school budget by School Board Treasurer Peggy Moede, Kevin Scott served as the temporary chairperson during the election of the permanent chairperson, called the meeting to order at 6:47 p.m.

#### **ELECTION OF A MEETING CHAIRPERSON**

Peggy Moede moved to nominate Kevin Scott as the Chairperson of the Annual Meeting. Kim Khoury seconded and the motion was carried unanimously by a voice vote.

#### **APPROVAL OF ANNUAL MEETING MINUTES**

Peggy Moede moved to approve the minutes of the August 26, 2021 Annual Meeting as presented. Kim Khoury seconded and the motion was carried unanimously by a voice vote.

#### **OLD BUSINESS**

Board President Scott highlighted the achievements of the 2021-22 year including this past year being one of resiliency which shone through when it was reported that Swallow received the top marks in the state on its Department of Public Instruction report card for the 2020-21 school year and noted that while this was wonderful news, Swallow is not immune to issues that are also plaguing other school districts in Wisconsin such as inflation causing budgetary pressures and the competition for top-level teachers and other staff is significant.

Among the additional achievements of the District noted was the newly-adopted teacher pay model that rewards teachers that look to achieve and improve themselves professionally, as well as those who stay with the District long-term, which will help attract, and retain, outstanding teachers that will be part of Swallow's continued long-term success.

Mr. Scott additionally mentioned the Board's creation of two new committees to create efficiencies in Board work in the areas of Policy and Curriculum and lauded the national reputation of the District in attracting families who have the choice to relocate to many places who have chosen Swallow.

Thanks were given for the excellent work done by administration and staff in leading the search for new Assistant Principal Anton Shircel as well as several new teacher and support staff hires as well.

### **NEW BUSINESS**

Kim Khoury motioned to keep the current salary at \$2,500 for school board members, Haley Sweeney seconded and the motion carried on a voice vote.

Haley Sweeney moved to approve a tax for the operation and maintenance of the school General Fund (Fund 10) in the amount of \$4,249,150, and Debt Retirement (Fund 39) in the amount of \$576,086, for a total of \$4,825,236 to be levied upon the

taxable property of the school district for the 2022-23 school year. Kim Khoury seconded and the motion was carried by a unanimous voice vote.

### **OTHER BUSINESS**

There was no other business discussed.

### **ADJOURNMENT**

Peggy Moede moved to adjourn the Annual Meeting. Wendy Szafranski seconded and the motion was carried unanimously on a voice vote. The meeting ended 6:58 p.m.
